BROADNECK AREA YOUTH SPORTS

Purpose: Broadneck Area Youth Sports (B.A.Y.S.) (the “Organization”) collects and stores player and family information in the registration process. This policy defines the Organization’s responsibility regarding the privacy of such information, and sets forth the basic rules for granting access to a player’s information.

Plan:

Player and Family Information

The Board of Directors recognizes the responsibility to protect the privacy of its members. All of the information gathered in the registration process shall be used by the Organization only for the purposes for which it was intended. Registration information is considered confidential, and is presumed to be intended for use and disclosure in connection with any and all activities of the Organization.

Commissioners, coaches, team coordinators and other volunteers (“Volunteers”) will be periodically granted access to player information, including limited and unlimited access. It is the responsibility of a Volunteer to use player information only for the purposes for which it is intended.

At no time shall a Volunteer with access to player information use such information for personal or financial gain. A Volunteer shall not share membership information or solicit membership for any third parties or unintended recipient without the express written approval of the President. Unintended recipients shall include, but not be limited to, high schools, recruiters, clubs and independent service providers. A Volunteer is permitted to disclose such player information to Anne Arundel County Parks and Recreation, MD, and such other leagues the registration fee was specifically intended.

It is intended that names, email addresses, home addresses, phone numbers and other such information will be shared with Volunteers and members of the Organization for the purpose of coordinating teams and/or communicating with the Organization at large. In addition, it is expressly intended that such information may be used for purposes of fundraising for the Organization.

Payment and Financial Information

The Organization does not have access to debit or credit card information provided during registration. An independent service provider shall manage all privacy policies regarding this information. Currently Bonzi Inc.

Player Profile Access

It is the responsibility of the parent or legal guardian of a member to periodically update a player’s information in the event information changes. It is the policy of the Organization that two parents of the player, and/or the legal guardian, shall be included in, and granted access to, the player’s profile. Parents and guardians may mutually agree to an alternate arrangement,
